During the pregnancy of her second child, she realized that she couldn't go on without Christ as the center of her life. Shortly afterward, she was offered a job at one of the oldest and largest hotels in the Shore area. There she was able to live in a suite with her second daughter. Kelly established such a wonderful environment and stability that the courts released her first daughter to her custody after four years of separation. Love INC was honored to also give Kelly a car through our Wheels Appeal program. She was then able to go to work and to take her girls to day care, to the doctor, and to church.

Since then after much prayer, Kelly decided to move her family to a rural area of Massachusetts where the cost of living is less expensive. Love INC thought it a privilege to pay the cost of her U-Haul as she re-established her life. In Massachusetts, Kelly has joined her mother, a known artist in the area, and is

now living in a beautiful Victorian house that sits on a mountain overlooking a valley. Kelly has not only *moved on*, but *moved up* with a new found life and a happy united family. Praise God!
