Dear Love INC supporters,

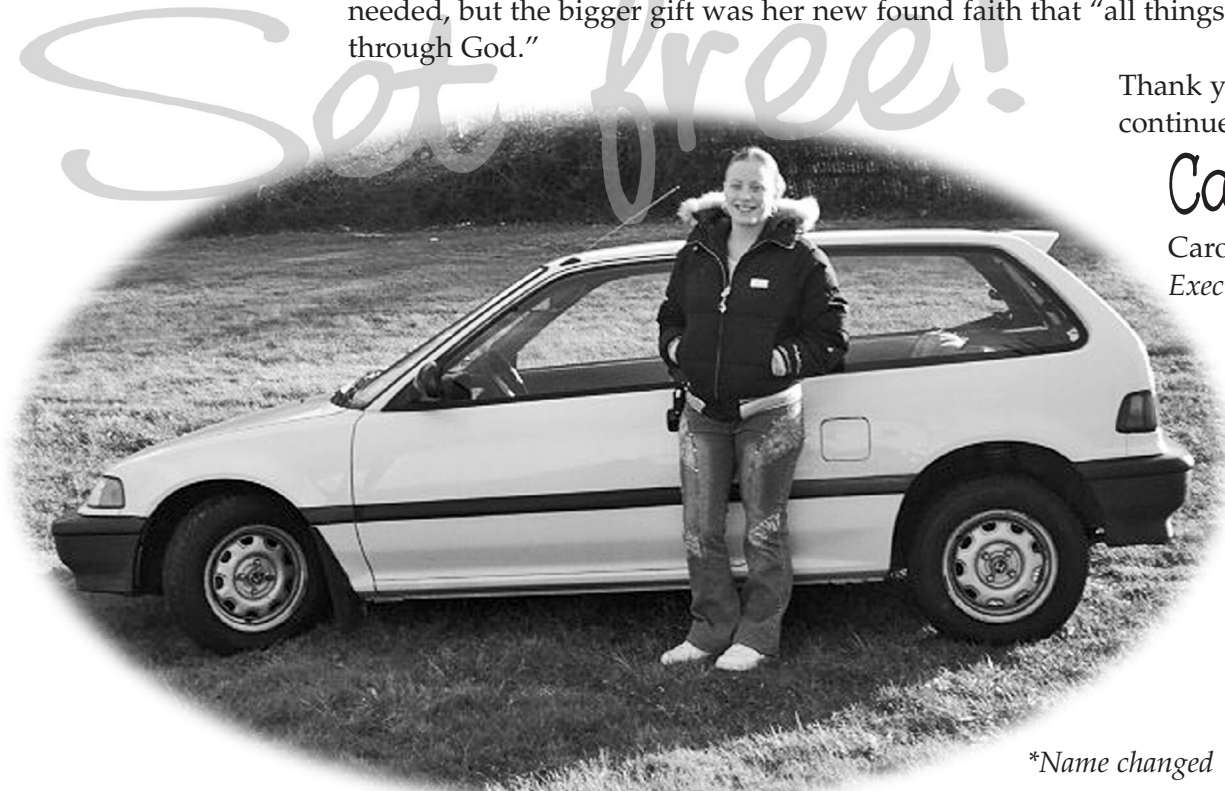
We praise God when we see a changed life happen before our eyes!!
